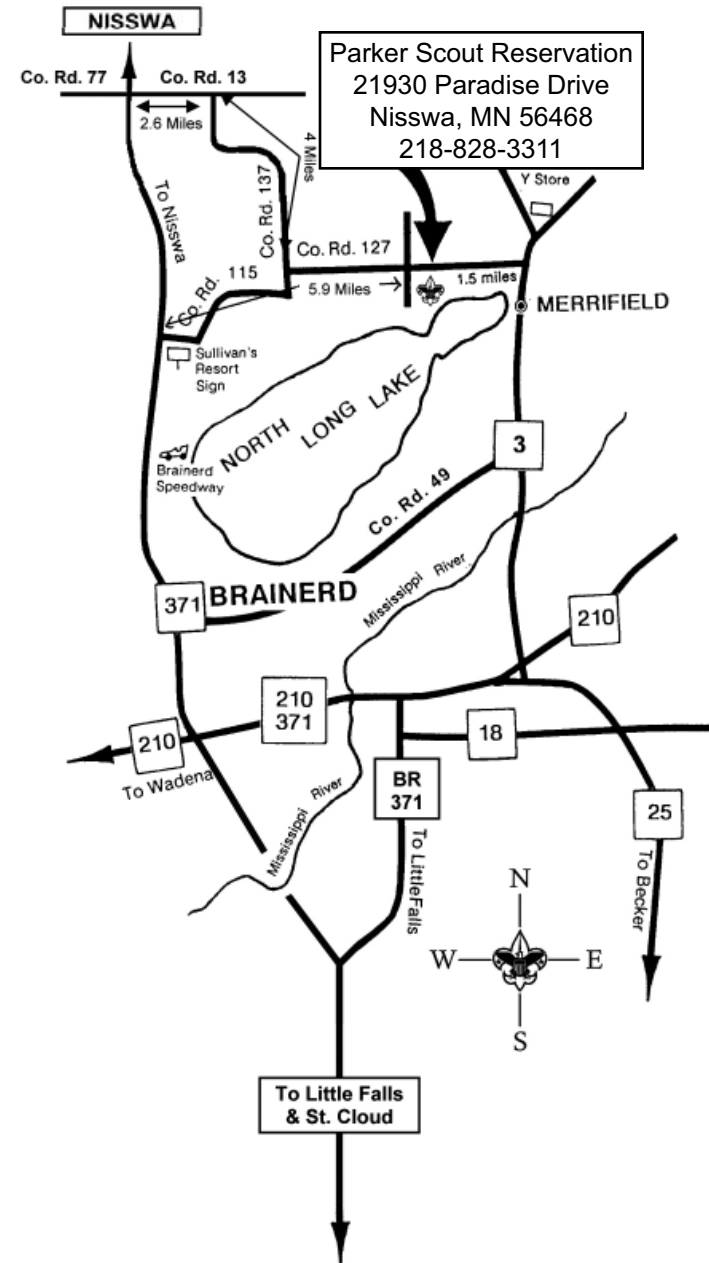

# PARKER SCOUT RESERVATION

- ♣ Located on North Long Lake, 10 miles north of Brainerd, PSR is 256 acres of forest and fun!
- ♣ PSR is a great place to go camping during any season. The camp is quiet and has much to offer; including fishing, hiking, the Paul Bunyan bike trail, cross-country skiing, tobogganing, and games.
- ♣ PSR cabins can accommodate approximately 80 people. The 12 wooded campsites are available year-round for those who want a real outdoors experience.
- ♣ PSR provides Scout groups and other like-minded youth organizations the opportunity to enjoy outdoor activities which are endorsed by the Boy Scouts of America.
- ♣ PSR is used extensively for Scouting activities throughout the year. Scout groups are given first priority on all rentals.
- ♣ PSR is operated and maintained by the Central Minnesota Council, BSA for its members and guests. Programs and activities are open to all youth regardless of race, religion, or country of origin.

A two week advanced notice is requested for all reservations.  
All reservations are subject to camp availability.

Cancellations must be made at least two weeks prior to reservation date or the deposit will be forfeited. However, if the Central MN Council, BSA is able to find other suitable renters, the deposit will be refunded.

# RENTAL INFORMATION

- ♣ All rental prices are for Friday evening until Sunday noon. Weekly rates are available upon request.
- ♣ The rental deposit for building use is \$125. The deposit will be refunded when buildings, campsites, and equipment meet the check-out standards of the Central MN Council, BSA. Any repair, replacement, or cleaning cost will be billed to the renter.
- ♣ Rental fees are in addition to the rental deposit and must be paid before arriving at Parker Scout Reservation.
- ♣ Check-in and check-out must be done through the Camp Caretaker or Campmaster.
- ♣ All buildings and campsites have nearby pit toilets or indoor toilet facilities.

# FACILITIES RENTAL FEES

<b>Campsite</b> - Wooded campsite with fire ring.	no charge
<b>Family Campsite with One Electrical Hook-up</b> Large wooded campsite with electricity near the beach.	\$50
<b>Dining Hall with Kitchen</b> - Seats 150, heated, year-round water, showers, bathrooms, plus stoves, refrigerator, etc.	\$150
<b>Miller Castle</b> - Sleeps 50-80, heated, year-round water, showers, bathrooms, kitchen, dining hall, and much more!	\$10/person \$500 min.
<b>Parker Lodge</b> - Sleeps 18-24, heated.	\$125
<b>Craft Lodge</b> - Sleeps 30-36, heated.	\$125
<b>Akela Lodge</b> - Sleeps 8, heated, and screened porch.	\$50
<b>Shower House</b>	no charge
<b>Day Use of Facilities</b> - No buildings used.	no charge

# EQUIPMENT RENTAL FEES

<b>Archery</b> * - includes bows and arrows	\$5 per person
<b>BB Guns</b> ** - includes BB guns and BBs, available June, July, and August only	\$5 per person
<b>Canoe</b> *** - includes life vests	\$10 each
<b>Canoe Trailer</b> - with 8 canoes and life vests (trailer only -\$50)	\$125
<b>Rowboat</b> *** - includes life vests	\$5 each
<b>Sailboat</b> *** - includes life vests	\$10 each
<b>Cross-Country Skis</b>	\$5 per pair
<b>Snowshoes</b>	\$5 per pair
<b>Bicycle</b>	\$5 each

\* Must have a certified archery instructor on-site. \*\* Must have a certified firearms instructor on-site.

\*\*\* Must have a certified aquatics person on-site.



# RULES & PROCEDURES

1. **Alcoholic beverages** of any kind are strictly prohibited.
2. **Aquatic activities** are only permitted when a certified lifeguard is present and must be conducted in accordance with the Boy Scouts of America standards.
3. **Camp usage** must be authorized by submitting a written application through the Central Minnesota Council, BSA. All applications will be confirmed in writing.
4. **Fire Prevention**
  - a. *"No flames in tents"* is enforced. Liquid fuels, stoves, lanterns, etc. must never be used in or near tents.
  - b. The use of liquid fuel to start a fire is strictly prohibited.
  - c. Liquid fuels must be labeled and stored safely.
  - d. Only use designated campfire areas. No pit fires are permitted without written authorization.
  - e. Always extinguish fires properly and never leave any fire unattended.
5. **Firearms**
  - a. Personal firearms of any kind are strictly prohibited.
  - b. Camp firearms may be used under direct supervision of a certified firearms instructor. The rifle range is the only designated shooting area.
6. **Fireworks** of any kind are strictly prohibited.
7. **Personal pets** of any kind are strictly prohibited. Service animals are allowed but must be listed on the application.
8. **Prescription medications** must be in original containers.
9. **Standing trees** must never be cut for any reason.
10. **Trash and litter** must be brought to the dumpsters in the maintenance area on a daily basis.
11. **Trenches** must never be dug around tents. Remember... *"Proper pitching avoids ditching"*.
12. **Vehicles and Trailers**
  - a. Vehicles must be parked in the central parking lot area.
  - b. Vehicles used to transport people or gear to the wilderness campsites must have advanced approval.
  - c. Truck beds or trailers must never be used to transport people anywhere at Parker Scout Reservation.
  - d. The camp speed limit is 10 mph maximum.

***Permission to use Parker Scout Reservation is granted to groups or individuals on the basis of understanding and accepting these rules and procedures.***

***Violators will be asked to leave camp immediately. Refunds will not be given to any groups or individuals that are asked to leave camp under any circumstance.***
